IN ADDITION ANOTHER CONSULTANT WAS ENGAGED THIS YEAR TO LOOK AT THE OVERALL STRUCTURE OF THE CEO'S COMPENSATION PACKAGE TO INSURE THAT IT IS IN LINE WITH THOSE OF SIMILAR ORGANIZATIONS.
